MEMBERSHIP REPORT 2025

Overview

Overall, as at 30 June 2025, the Friends had:

- 201 financial subscriptions, and 25 non-financial subscriptions (members whose subscription had expired, and renewal notices had been sent).
- This amounted to 292 financial members, 335 including lapsed members.
- A number of memberships moved from double to single during the renewal process this year, potentially a reflection of tighter economic conditions.
- Renewal rates dropped slightly year on year from 74% to 60%

Annual Memberships FY24-25

The Friends saw 73 new and renewing annual financial members pay subscriptions in the 2024-25 year, down 4 on last year, which was down 5 on the previous year.

Of these:

- 29 were new members and 44 were renewing members a 60% renewal rate (down from 75% last year, but consistent with 2022-23, and well above the 34% renewal rate in 2021022.
- 43 were single memberships, 27 were double/family, and 3 were students, marking a continued shift from double to single memberships.

Life Memberships FY24-25

No longer offered as a membership tier, Life Memberships (formerly Members in Perpetuity) have remained consistent at 64 Double and 64 Single memberships. Life Membership subscriptions are held in an investment fund by the Friends, with the proceeds supporting operations and activities.

Membership management

Membership continued to be managed by the Gallery team this year, with very appreciated support from committee member Carol Boyle to compile and distribute the new and renewing member packs.

Due to multiple ways of joining and updating information, the membership process has not been as consistently seamless as hoped, but looking forward, the committee and gallery team are together exploring new tools to streamline the process and take some of the work out of the renewal process, noting that the gallery have fewer resources to support this function.

FINANCIAL REVIEW REPORT 2025

Year to 31 October 2025

Friends of the Govett-Brewster Art Gallery / Len Lye Centre Inc.

I'm pleased to report that the Friends remain in a stable financial position as at 31 October 2025. Our total assets sit at just under \$34,000, made up of approximately \$10,000 in our operating account and \$24,000 held in a term deposit. We have **no liabilities**, and although the current year shows a small deficit of around \$1,400, this reflects the timing of expenses rather than any structural issue with income or cash flow. Compared with last year, our overall position has dipped slightly—by less than \$200—but remains stronger than at the same time two years ago.

Last financial year, to 30 June 2024, we achieved a surplus of just over **\$4,000**, driven mainly by membership subscriptions and interest income, with very low operating costs and no major events expenditure. Our strong renewal rate of **75**% shows the value members place on staying connected, and it gives us a solid foundation for the year ahead.

Looking forward, we have two key financial priorities: first, continuing to honour our \$3,000 per year commitment to support the Artist in Residence programme; and second, working toward the longer-term goal of building a \$50,000 investment fund with the Taranaki Foundation, which would generate ongoing support for Gallery initiatives. With around \$34,000 already on hand, we are well on the way, and a focused fundraising effort in 2026 could help us close that remaining gap.

Overall, the Friends remain in good financial health—conservative in spending, steady in income, and moving toward a more sustainable, future-focused funding model. Thank you to all members whose subscriptions, time, and support make this possible.

Membership context (latest reported year FY23–24)

• 77 financial members; renewal rate lifted to 75% (from 58% the prior year), with majority in New Plymouth and nearby towns. This underpins membership-fee stability heading into 2025.

Commitments & strategic settings relevant to 2025

- Artist in Residence support: \$3,000 p.a. for three years approved (multi-year). Ensure provisioning in the 2025/26 budget.
- Investment strategy under consideration: build reserves to \$50,000 with the Taranaki Foundation to target ~10% annual return for Gallery priorities; as of Oct 2025 liquid funds total \$33,911.46, implying a fundraising gap of ~\$16,000 to reach the threshold.

Recommendations for 2026 planning

- Cash stewardship: Maintain the \$24,000 term deposit until a formal endowment decision is approved; shop rates at rollover.
- Targeted fundraising: Launch a focused appeal in early 2026 to close the ~\$16k gap to the \$50k endowment, aligning messaging with programme outcomes promised by the ~10% annual return model.
- Membership revenue: Build on the 75% renewal rate with a lapsed-member reengagement stream and consider modest subscription adjustments at AGM (noting annual subscription-rate setting is on the agenda).

- **Events economics:** Re-introduce 1–2 **pre-sold**/low-risk events to diversify income while keeping costs predictable (given 2024's low expense base and absence of event revenue).
- **A-in-R provisioning:** Ring-fence **\$3,000** for the Artist in Residence commitment in the FY26 budget and minute a drawdown schedule for transparency.

PRESIDENT'S REPORT 2025

Introduction

As President of the Friends of the Govett-Brewster Art Gallery | Len Lye Centre, it is my privilege to present our Annual Report for 2025. This year has been one of steady progress, with refinements to our Friends processes and expanded benefits for our members.

Highlights of the Year

Support for the Artists in Residence Programme: You may recall that last year's AGM began with a talk and display of Kiti by Maureen Landur. Maureen was our first artist to be supported this year, and her exhibition was special. The Friends committed most of our annual budget to support this program, and it has certainly paid dividends.

Exclusive Friends' Tours: Our private Friends' tours prior to exhibition openings have proved very popular. I particularly appreciate the insights and context provided by the artists and curators, which help strengthen our connection to those we support through the Artists in Residence Programme.

Member Events: The committee has continued to organise events for members. In February, we celebrated Monica's birthday with an art-and-music event at the old Kriesler Homestead. More recently, we arranged a bus trip to support the Taranaki Arts Trail.

Operational Improvements: Smaller but important wins this year included refreshing the Friends banner and issuing EFTPOS cards to simplify minor transactions.

Review of the Term "Patron": At last year's AGM, our patron Fiona Clark questioned whether the term "Patron" remains relevant. Over the past year, we researched and consulted widely on the matter. While many might not view it as a pressing issue, the term historically implies financial sponsorship, which does not align with the role of our Friends patron. After thoughtful discussion, we have adopted the te reo Māori term "Hoa Hāpai", combining hoa (friend) and hāpai (to lift, raise, or support).

Looking Ahead

The coming year offers further opportunities to refine our processes. A key focus will be automating the Friends membership renewal system and verifying the accuracy of our contact database.

Strengthening our social media presence is also a priority, especially as our social media coordinator, Rebecca Johnstone, has moved on after contributing significantly during the past year.

Additionally, as an incorporated society, the Friends must renew our constitution. This is an involved process, and we plan to circulate a draft for consultation and ratification in the new year.

On behalf of the Friends, I extend heartfelt thanks to the staff of the Govett-Brewster Art Gallery | Len Lye Centre for their ongoing support and partnership.

I wish to acknowledge Antony, Fran, and Zara for hosting our meetings and championing our initiatives.

GALLERY DIRECTOR'S REPORT 2025

The last year was a successful one for the Gallery, with the ongoing support of our Friends making a positive difference.

We welcomed over 79,000 visitors to the gallery – well above our 72,000 target. Of these, almost 13,500 attended the Len Lye Centre Cinema, 4,000 came on a school visit, 300 attended a Monica Brewster Evening event, and 6,600 attended one of 79 other events and public programmes developed and delivered by our team. 14,255 of our visitors - 18 percent – were from out of town and paid to enter our Gallery.

We delivered seven exhibitions: Without Centre Without Limits, Interlaced, Lalaga: Le Hui Fono, Motion Compositions, Stitching Solidarity, Direct Bodily Empathy, He Tukutuku Auahatanga: Maureen Lander with community, with Friends having advance access to all for a mix of guided tours, talks and social occasions.

We added six new works to the Govett-Brewster Collection, welcomed three new sponsors to our partners, and delivered a total of 89 public engagement events.

Significant effort went into producing a book on the Len Lye Centre – available now with a Friend's discount - as well as celebrations for the Centre's 10th anniversary. It was great to see so many Friends – present and past – attend the performances by the New Zealand Symphony Orchestra in the Gallery at the end of August to mark this occasion.

I gratefully acknowledge the mahi and support of our Friends group, from the President and Committee who tirelessly advocate for the Members in Gallery conversations and the Gallery in the wider community, and the many Members who make Friends events so enjoyable.

I particularly want to thank the Friends for their direct programme support this year which enabled our artists in residence to spend more time in Ngāmotu, working with our team and our community. At a time when budgets across the board are tightening, wallets are staying firmly in pockets, and people are increasingly reluctant to put their hands up in defence of the Arts, this support has made a real and tangible difference.

And that is exactly what good Friends do: they build us up in the tough times and share the joy of the good times.
